Bottlenecks/issues/action required, if any:

- 1. Against total sanctioned Central Financial Assistance (CFA) of Rs 65.54 crore, only Rs 22.19 crore have been released by the MNRE for two components pertaining to Jammu and Kashmir. Due to non-availability of sufficient funds, the S&T Department is not in a position to complete the projects in time.
- 2. For procurement of Solar Home Lighting Systems (SHLSs), MNRE was requested to revise the CFA and approve procurement of Model IV instead of Model II.
 - MNRE vide letter dated 23.04.2019 has conveyed that CFA from MNRE would be restricted to 90% of the cost of Model-II SHLS arrived through tendering process i.e., Rs 3780.00 per SHLS, irrespective of Model-II or Model-IV SHLS installed by JAKEDA.
- 3. Also, MNRE has to accord time extension for the projects, otherwise the Department would not be in a position to execute the project of SHLSs in toto. In the meantime, sanction of 25,000 SHLSs meant for Jammu division has become invalid.
- 4. CEO JKEDA vide his communication No. ST/EDA/Plan/95/2015/198-99 dated 30.06.2021 has requested for deletion of the Project "Solar Off-Grid Home System/ Street Lights" from the ongoing PMDP projects for review of the physical progress and issues/ concerns related to the projects.
- 5. JKEDA has taken up the issue of release of balance commensurate Central Financial Assistance (CFA) with the central Ministry for an amount of Rs. 7.28 against the two projects.
- 6. Similarly, balance UT share amounting to Rs. 7.98 crore under Solar Off-Grid Home System stand projected under Capex Budget during the current fiscal.

➤ Release of Rs 7.28 crore central assistance awaited from MNRE GoI.
